



PRESIDENTIAL FELLOWS PROGRAM APPLICATION INFORMATION

The CBA wishes to further encourage and increase the active involvement of talented early- and mid-career lawyers from all backgrounds in the leadership and activities of CBA sections. Through the CBA Presidential Fellows Program, Fellows will be matched with a CBA section that aligns with their interests and experience. Within their section, Fellows will have an opportunity to become more involved in the substantive work of the section, serve on the section's executive committee, engage in a key section project or program, and further develop their leadership skills. Fellow appointments are prestigious, and we expect a competitive application process.

Benefits of Being a CBA Presidential Fellow:

- Serve on the executive committee of a section as ex-officio member;
- Be matched with a section executive committee member who will serve as a mentor and advocate, helping the Fellow to be integrated in the leadership of the section;
- Be invited to educational and leadership development events for Fellows at no charge;
- Attend section meetings;
- Become involved in or lead a key section project;
- Present at a section meeting;
- Receive a waiver of all fees for membership in a section and that section's events.

Eligibility and Selection:

The CBA Presidential Fellows Committee reviews all applications and makes selection decisions. To be eligible to apply, applicants must meet the requirements below:

1. Have demonstrated talent and strong leadership experience or potential;
2. Be a licensed lawyer in Connecticut in good standing with at least one and fewer than twelve years of professional experience as a lawyer; and
3. Be a current member of the CBA, or commit to joining the CBA as a dues-paying member if selected as a Fellow.

Special consideration will be given to lawyers in government or public interest service, lawyers who have overcome adversity, and lawyers who are first-generation lawyers (i.e. the first in their family to become a lawyer). Previous membership in the CBA or a CBA section is *not* required.

Additional Information:

While there is no cost to apply to be a Fellow and no fee to participate in the CBA Presidential Fellows Program, Fellows are required to be active dues-paying members of the CBA and must timely pay their annual CBA membership dues for the duration of their term. Fellows are appointed for a term of two bar years.

To remain in the program for the full two-year term, Fellows are required to (1) attend meetings and actively participate in section activities, (2) attend all mandatory Fellows events (unless excused by the Program Chair), (3) remain current on their CBA membership dues and in good standing with the CT bar, and (4) ensure the CBA has current contact information for the Fellow, including phone, email, address, and employer.

To Apply:

Prospective Fellows must submit the following by August 14, 2026:

1. Completed application form,
2. Application statement describing why you are interested in participating in the CBA Presidential Fellows program and how you plan to contribute to a CBA section (200 words or fewer),
3. Resume, and
4. Two letters of recommendation.
