### Eligibility

1. Must be a junior, senior, or graduate of a Connecticut-area college or university (meaning schools located in Connecticut or in Western Massachusetts)
2. Must be committed to pursuing a law degree at an accredited law school in the Connecticut-area (including law schools located in Connecticut and Western Massachusetts) or pursuing a legal career in the Connecticut area in the future.
3. Applications are welcome from all aspiring law students that meet the prior eligibility criteria. Preference will be given to first generation law students (meaning students who would be the first member of their immediate family to attend law school) with a demonstrated commitment to advancing diversity, equity, and inclusion in prior academic, professional, or personal pursuits, or who are able to demonstrate that the applicant has overcome adversity or other challenges in the pursuit of a future career in the law.

**Additional Information:** Accepted Scholars will be alerted via email regarding their application status. Scholars will then be enrolled in a Princeton Review LSAT prep course by the CBA when the Scholar is beginning preparation for the LSAT. Scholarships will be paid directly to The Princeton Review to cover the associated fees for the course.

Accepted Scholars will also be invited to participate in enrichment and networking programs during the year to learn about the law school application and admission process, engage and connect with the Connecticut legal community, and prepare for future matriculation to law school.

Personal Statement Two: In 500 words or fewer, tell us why you think diversity, equity, and inclusion are important to the legal profession. Please also tell us how you have sought to advance diversity, equity, and inclusion in your prior academic, professional, or personal activities and experiences. Please also share with us if you have experienced adversity or barriers in your pursuit of a future career in the law, and how you have responded to those challenges.

### **IV. Letter of Recommendation**

The letter of recommendation should speak to the applicant's academic performance and/or professional qualifications. Reference to the applicant's future aspirations in the legal field are preferred. Please be as detailed as possible.
