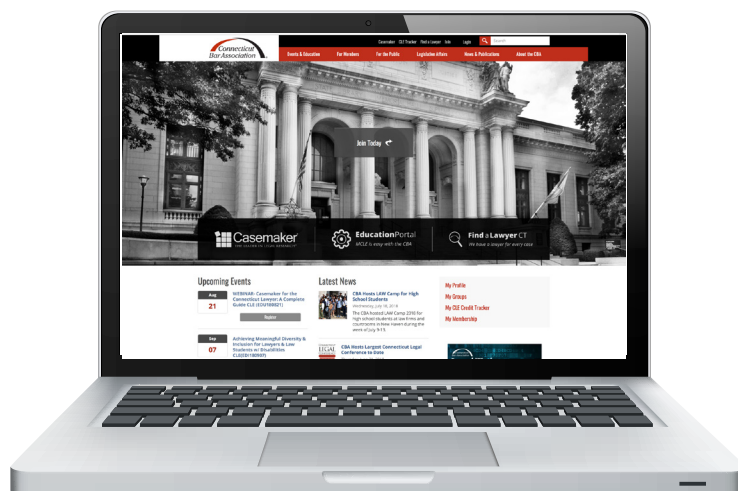

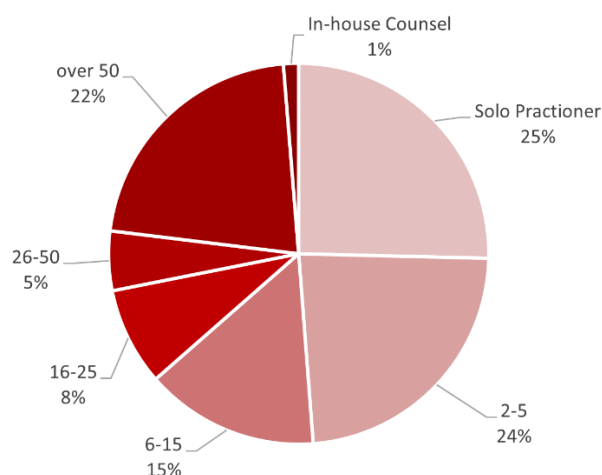


About the CBA

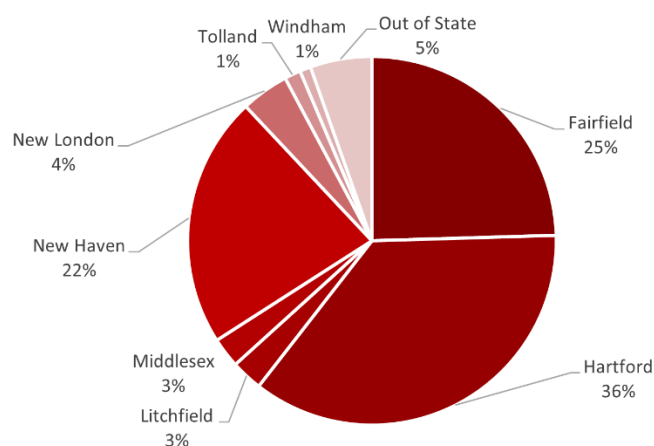
