The second bill signing was Public Act 16-71, An Act Concerning Human Trafficking. The work of the Sex Trafficking Task Force underscores how lawyers can make a difference, and I am proud of the CBA's efforts to fight the scourge of human sex trafficking.

Diversity Summit

A subcommittee of the Diversity and Inclusion Committee met all summer and worked tirelessly to plan for the first Diversity Summit in Connecticut. It will bring together the leaders of our legal community to create a collaborative blueprint for improving diversity and inclusion. The Summit will be taking place at Quinnipiac Law School on October 26. It will be followed by the Young Lawyers Section Diversity Dinner at Amarante's Sea Cliff in New Haven. I am hoping that this one day will be looked back on as a turning point in our legal community. On a related note, the Diversity and Inclusion Committee approved a diversity and inclusion template for our sections to use in considering how best to increase diversity and inclusion on the section level.

Secretary's Legal Assistance Program ("SLAP")

Secretary of the State Denise Merrill and the CBA developed the Secretary's Legal Assistance Program to assist Secretary Merrill on Election Day. I met with the secretary and held a conference call with other bar leaders to introduce them to the program and obtain their support. Under the program, trained volunteer attorneys will be on call throughout the state on Election Day to assist the secretary if a problem with voting arises at a polling place. We are working with the secretary's office to set up a training webinar at the end of October. Our great democracy relies on the ability of those who want to exercise their right to vote be able to do so.
