CBA Federal Practice Section Participates in Unveiling Portraits of Retired Magistrate Judges

In June, the Connecticut Bar Association's Federal Practice Section participated in the unveiling of portraits of four retired U.S. Magistrate Judges at the Richard C. Lee Courthouse in New Haven, who have served the court of a combined period of over 100 years. These judges were Hon. Arthur H. Latimer, Hon. F. Owen Eagan, Hon. Thomas P. Smith, and Hon. Holly B. Fitzsimmons.

Among those offering remarks at the ceremony were James Ross Smart and Patrick A. Klingman, co-chairs of the CBA Federal Practice Section.

After opening remarks led by Chief Judge Janet C. Hall, U.S. District Court, District of Connecticut, the portraits were presented for each magistrate judge. Karen I. Clute, partner at Wiggin and Dana LLP (former law clerk of Judge Latimer), led the remarks for Magistrate Judge Arthur H. Latimer's portrait presentation.

He was identified as Connecticut's first full-time U.S. magistrate judge as well as having two law degrees (one from the University of Oxford and the other from Harvard Law).

Next, Michael Gustafson, assistant U.S. attorney, District of Connecticut (former Law Clerk of Judge Eagan), introduced Magistrate Judge F. Owen Eagan's portrait presentation. Judge Eagan was recognized for serving as magistrate judge for over two decades and, upon retirement, founded the Canterbury Resolution Center, a mediation firm located in West Hartford.

The third portrait, for Magistrate Judge Thomas P. Smith, was introduced by Rowena Moffett of Brenner Saltzman & Wallman LLP (former law clerk for Judge Smith). Judge Smith was acknowledged for being the longest sitting magistrate judge in the country and is currently serving the district as a recalled magistrate judge, with focus on settlements and mediation.

The presentations were concluded with Magistrate Judge Holly B. Fitzsimmons's remarks, spoken by Alyssa Esposito, (former law clerk of Judge Fitzsimmons). Judge Fitzsimmons was cited as serving as a U.S. magistrate judge for nearly 22 years and as being a member of the Federal Magistrate Judges Association as well as the Raymond Baldwin Inn of Court. The ceremony concluded with a reception that was held for all guests. **CL**

Court Visitation Program

Carmina Tessitore, The Law Offices of Carmina Tessitore, Shelton

It was in upstate New York while a student at Sage College working with juve-

niles that sparked Carmina Tessitore's interest in legal work, and continued at Albany School of Law. In the courts she became more fascinated with the process and experience of small claims and alternative dispute resolution. After deciding to return to Connecticut, and then being admitted to the Connecticut Bar in 2008, her involvement in the CBA began first in the Young Lawyers Section then as a member of the Alternative Dispute Resolution, Small Firm Practice Management, and Family Law Sections. Last year she served as chair of the Women in the Law Section.

Attorney Tessitore spends most of her practice with family law issues. Through serving as an adjunct professor at Quinnipiac Law and working with children in family practice, she became interested in the CBA'a Court Visitation Program, in which she started volunteering in 2013. This program continues to open her eyes to working with juveniles and their experience in the court system, and how the program can offer options to kids and make a difference through the tour.

The Court Visitation Program provides high school students with a backstage view of how the court system works. Each geographical area (GA) has a court visitation volunteer attorney who receives notice that a school is interested in a tour. That volunteer then contacts the school and coordinates a date with both the school and the court. The volunteer attorney meets the school at the court, sometimes with additional volunteer attorneys, and they start their 2-3 hour tour.

Attorney Tessitore works with both GA 1 (Stamford) and GA 20 (Norwalk). She schedules tours for the students to experience how court works by sitting in a Q&A with a judge, prosecutor, and public defender to talk about how they got involved in their professions and what it entails. In some courts, the marshals share their experiences and occupation. They also talk about why they have chosen this career, and explain that the court is not like TV. The students ask about murder cases, domestic violence, drug cases, favorite cases, and disappointments. The students then sit quietly through arraignments, and sometimes criminal cases, to finish their tour.

Giving the tours is a reminder of why Attorney Tessitore chose her profession. The tours give other options to the students and shows them how they can make a difference. Almost all the students state that they are not interested in a legal career. However, the tour brings the experience to a human level and the potential professions they could choose.

The Court Visitation program is co-sponsored by the Connecticut Bar Association, the Connecticut Judicial Branch, and the Connecticut Judges Association. **CL**
