Why Access to Civil Legal **Services Matters**

While CBA members and policymakers advance Connecticut's Civil Gideon movement, establishing an important right to counsel in civil legal cases, Statewide Legal Services of Connecticut, Inc. (SLS) continues to work with the CBA in challenging the pri-

vate bar to provide pro bono legal representation for our low income clients. Indeed, the demand for legal representation by this population continues to rise and cannot be met by just the legal aid programs alone.

SLS pro bono attorney and CBA member, Peter Appleton, of Appleton & Appleton LLC, accepted this pro bono challenge by representing a low-income father who had been victimized by his landlord.

Attorney Appleton successfully utilized the Connecticut Unfair Trade Practice Act (CUTPA) to secure a \$225,200 judgement in damages, plus an additional

\$15,000 in attorneys' fees, against a landlord who unlawfully locked out this low income father and his family from their vermin-infested apartment, threw away the family's belongingsincluding personal identification and family photographs-and sent taunting text messages, containing photos of the dumpster, to the client's phone.

In his decision, Judge Grant H. Miller, Jr. found for the tenant on his counts of forcible entry and detainer and infliction of emotional distress, saying that for all the countless acts of "callousness, mean spiritedness and arrogance," he had seen in his 38 years of trial and jurist experience, this case offended him the most. The judgement is now on appeal.
