already on the hospital's premises for other duty related activities and took it upon himself to check on the security of the patient. For the dissent, "it was of no moment that the [trooper] did not act in response to a formal request by the defendant for assistance, but rather, exercised his own initiative to check on, and ultimately subdue [the patient]."

So, where is all this headed? We're not sure, given that of the four justices in the majority, one is already retired, one is soon to retire, and two are already on senior status. Meanwhile, the members of the concurring side continue to serve, rendering this issue one that will be interesting to watch in the coming years. CL
