CONNECTICUT BAR ASSOCIATION New Sector Sworn In to the Connecticut Bar



On October 26, 127 new attorneys were sworn in to the Connecticut Bar at the Connecticut Supreme Court building. Chief Justice Richard A. Robinson and Associate Justices Joan K. Alexander, Gregory T. D'Auria, Steven D. Ecker, and Andrew J. McDonald presided over the two ceremonies held during the day in the morning and the afternoon.

The morning and afternoon ceremonies began with welcome remarks and words of recognition provided by Chief Justice Robinson. He spoke about recent challenges facing the rule of law in the United States and noted that those being sworn in as attorneys have the responsibility to uphold, defend, and promote our laws and the execution of justice within the American legal system. Justice Robinson stated, "Each one of us has the ability and the responsibility to take the lead in support of the rule of law and to defend liberty and the pursuit of justice."

Following the administration of the oath of attorney, CBA President Daniel J. Horgan provided welcoming remarks to the newly inducted attorneys at both ceremonies recognizing their great achievement. He cautioned the newly admitted

CBA Hosts 2022 New England Bar Association Annual Meeting

The Connecticut Bar Association (CBA) hosted the 2022 New England Bar Association (NEBA) Annual Meeting at Water's Edge Resort and Spa in Westbrook October 27 to October 29. Leaders from the state bar associations throughout New England were invited to participate in the meeting, which consisted of educational programs covering contemporary legal topics and opportunities for socializing.

The event began on Thursday evening with a welcome reception for arriving attendees. The next day began with opening remarks for the meeting, presented by NEBA and CBA President Daniel J. Hor-

zations throughout New England; and Supreme Court Chief Justices Gordon MacDonald (NH), Stuart Rabner (NJ), Paul Reiber (VT), and Richard A. Robinson (CT).

On Friday evening, attendees met for a cocktail hour and dinner, followed by a standup comedy performance and music and dancing. During dinner, outgoing NEBA board members were recognized with certificates, incoming board members were introduced, and a symbolic passing of the gavel took place between President Horgan and incoming NEBA President Damian Turco.

On Saturday, the final day of the annual meeting, American Bar Association President Deborah Enix-Ross joined

the event to discuss her "three Cs" initiative, focused on civics, civility, and collaboration. The final education program focused on the responsibility of lawyers and bar leaders to address increasing polarization within the United States through the promotion of constructive and informed discourse.

in 1998. He was active in the community, including on the Board of the St. Mary's Hospital Foundation, on committees of the Connecticut Bar Association, and coordinated the Traurig Scholarship Trust at B'nai Israel.




Cameron F. Hopper passed away on August 26 at the age of 89. He graduated from Trinity College and Yale Law School.

He served in the Connecticut Air National Guard from 1958 to 1964. After law school, Attorney Hopper was employed by the Greenwich law firm of Ivey Barnum & O'Mara, where he practiced until he was elected probate judge for the Town of Greenwich in 1967. He served as the Greenwich probate judge for 23 years, while also practicing law as a solo practitioner, until 1991. Thereafter, he continued to practice law with his son, David, and several other partners, until his retirement in December 2016.
