Aware of a likely defeat in the Senate, the governor and Justice McDonald agreed to go forward with the nomination of McDonald to the Office of the Chief Justice of the Connecticut Supreme Court. The governor placed McDonald's name as chief justice nominee before the senate on Tuesday, March 27, 2018. It did not happen. He was voted down 19-16 with one democrat recusing herself and one democrat flipping to vote with the Republicans.

The Republican issues with Justice McDonald includes his involvement, while chairing the Judiciary Committee, in proposed legislation that later came before the Supreme Court; they felt he should have recused himself. They also felt he was too close to the governor as Stamford municipal attorney, and eventually governor's counsel. There was disagreement in Justice McDonald's decisions, including on the death penalty. Additionally, a concern was that he did not have any previous trial experience.

Early this week the governor will forward another name to nominate as chief justice. Because his first nominee was rejected, it must be submitted within five days from disapproval from the present Supreme Court justices (Palmer, Robinson, D'Auria). Justices Kahn and Mullins are still interim justices. Committee. Two people have filed chief justice paperwork in the past few weeks. If the governor does not name someone, the senior judge—if accepting—will become interim chief justice. The senior justice is Richard Palmer.

There are still a number of judges who have been re-nominated by the governor and have been approved in the Judiciary Committee. They have yet to be approved in legislative chambers. Thoughts are whether they have been held until the vote on Justice McDonald. There are also a number of new nominees that we are awaiting.

Angel Arce (D-House District 4, Hartford) has submitted his letter of resignation to the House of Representatives. Because of the timing, there will be no special election before the end of the session.
