

**CONNECTICUT BAR ASSOCIATION
SURVEY SWEEPSTAKES
Official Rules**

NO PURCHASE NECESSARY TO ENTER OR WIN. OPEN TO LEGAL RESIDENTS OF THE UNITED STATES AND THE DISTRICT OF COLUMBIA WHO ARE LICENSED ATTORNEYS, WHO ARE MEMBERS OF THE CONNECTICUT BAR ASSOCIATION AT THE TIME OF ENTRY AND WHO WERE MEMBERS OF THE CONNECTICUT BAR ASSOCIATION AS OF THE START OF THE SWEEPSTAKES PERIOD. MUST BE AGE EIGHTEEN (18) OR OLDER. VOID WHERE PROHIBITED BY LAW.

1. How to Enter. NO PURCHASE NECESSARY. A purchase will not increase your chances of winning. The Connecticut Bar Association Survey Sweepstakes (the "Sweepstakes") sponsored by the Connecticut Bar Association ("Sponsor") begins at **3:05pm ET** on March 24, 2026 and ends at 11:59pm ET on June 17, 2026 (the "Sweepstakes Period"). To enter, complete the brief Connecticut Bar Association Member Survey located at www.surveymonkey.com/r/VLGB6D2 during the Sweepstakes Period, including your name and contact information. Only one (1) entry per person.

Participation in the Sweepstakes constitutes participant's full and unconditional agreement to and acceptance of these Official Rules and the decisions of Sponsor, which are final and binding.

2. Eligibility. Open only to legal residents of the fifty (50) United States and the District of Columbia who are eighteen (18) years of age or older, who are members of the Connecticut Bar Association at the time of entry and were members of the Connecticut Bar Association as of the start of the Sweepstakes Period. Employees, officers and directors of Sponsor, advertising and promotion agencies, distributors, and individual retail licensees and the immediate family members (meaning spouses, parents, siblings, children and their respective spouses) and members of the households of the foregoing individuals are not eligible. **VOID WHERE PROHIBITED.**

3. Winner Selection and Notification. The potential winner will be selected in a random drawing by Sponsor or its designee on or about June 19, 2026 from among all eligible entries received in accordance with the entry procedures set forth in Section 1 above.

The winner will be notified by email and/or telephone number at the email address or telephone number he/she provided on the survey and must respond to the notification within one (1) week. Winner may be required to sign and return an affidavit of eligibility, a liability release, and, where lawful, a publicity release, within five (5) days of the date of issuance or prize will be forfeited.

If the winner is a minor in his/her state of residence, the prize will be awarded in the name of, or to, winner's parent or legal guardian who must execute all documents and agree to all obligations of winner, both on behalf of him/herself and on behalf of the minor winner, or prize may be forfeited and awarded to an alternate winner.

A prize will be forfeited and an alternate winner will be selected at random from the remaining eligible entries and confirmed in accordance with these Official Rules (i) if a selected prize winner cannot be reached within one (1) week following the initial notification attempt or if winner (or his/her parent or legal guardian) does not sign and return any required documents within five (5) days, (ii) in the event of non-compliance with any of the requirements of these

Official Rules, (iii) if the prize notification is returned as undeliverable or (iv) if a selected winner refuses the prize or is otherwise ineligible to receive the prize.

Three (3) Prizes: One (1) winner will be randomly selected from among the first 100 survey submissions to receive a \$150 gift card; one (1) winner will be randomly selected from among the first 400 survey submissions to receive a \$100 gift card; and one (1) winner will be randomly selected from among the first 1,000 survey submissions to receive a \$50 gift card. No winner shall receive more than one (1) prize (once an individual is selected as a winner of a prize, that individual shall not be eligible for a second prize).
