I am writing to you as Counsel to the Rules Committee of the Superior Court. The Rules Committee has received a proposal from the Judicial-Media Committee to amend Section 1-11C concerning media coverage in criminal proceedings.

**RE:** RC Proposal 2019-006a – Camera coverage of homicide cases involving sexual assault

Thank you for the opportunity to provide feedback on the proposed rule change to Section 1-11C regarding media coverage of criminal proceedings.

The proposed amendment would permit a judge to authorize camera coverage of a homicide case involving sexual assault provided the victim's family affirmatively consents to such coverage. The Judicial-Media Committee states that the general intent of the existing ban of camera coverage in court cases involving sexual assault charges is to protect victim privacy and, in a homicide case, those privacy concerns are largely absent. While we don't disagree that the privacy concerns may be less prevalent, we believe it is important to be clear about how media coverage of a homicide, including those involving sexual assault, may impact the family of the murdered victim.

Having said that, we support the proposed change although we respectfully suggest that the Rules Committee address two points of potential clarification. First, how is "family" defined? Will the court take the lead of the Judicial Branch Office of Victim Services' Advocate in identifying a family spokesperson? What if family members disagree about whether or not coverage should be allowed? Second, we suggest that clarifying language be added in the proposed "new" section regarding cases where a family member cannot be identified, clearly stating that camera coverage will not be permitted in those cases.
