Just FYI, S.B. 200 is different from the legal services proposal in a couple of ways and we will propose substitute language. Specifically, we believe that (1) judgments for the landlord should be removed after one year rather than "not earlier than one year" (line 16-17) and (2) the bulk data base sold by Judicial to commercial users should not include removed records, so that "actual knowledge" will not be an issue (line 27).
