Dear Justice McDonald and Honorable Members of the Rules Committee:

This letter is submitted by legal services organizations Greater Hartford Legal Aid, Connecticut Legal Services, New Haven Legal Assistance Association, and Statewide Legal Services in support of the Connecticut Bar Association proposal to Amend Rule 1.8 (e) of the Connecticut Rules of Professional Conduct to permit, in limited circumstances, a humanitarian exception to the prohibition on providing financial assistance to a client. The proposed rule change would provide assurance to legal services and pro bono attorneys that we can provide occasional modest financial assistance to indigent clients without running afoul of the Rules of Professional Conduct.

The current version of Rule 1.8(e)(2), of course, permits attorneys to pay "court costs and expenses of litigation" for indigent clients. However, legal services and pro bono attorneys sometimes face difficult situations in which they would like to provide assistance to indigent clients that is not clearly for court costs and litigation expenses. Attorneys might want to buy food for clients after a long day at court, for example, or give clients bus fare, so that they can run critical errands.

Currently, supervising attorneys find ourselves explaining to our colleagues and volunteers that the Rules of Professional Conduct bar us from providing such assistance if it is not clearly a court cost or litigation expense. This proposed change to Rule 1.8(e) will permit attorneys serving the poor to respond to clients' basic human needs without fear of committing an ethics violation.
