Ms. Walkley earned her Juris Doctor from Western New England University School of Law, cum laude, in 1980, and her Bachelor of Arts degree, cum laude, from University of Pennsylvania in 1977. She is admitted to the state and federal courts of Connecticut and to the New York Bar. She is a member of the Connecticut, Fairfield County and Bridgeport Bar Associations and was a former co-chair of the Real Estate Committee of the Fairfield County Bar Association for over 10 years, as well as President of the Connecticut Title Association from June 2015- June 2017 and is currently a member of the Connecticut Bar Association's Standards of Title Committee. 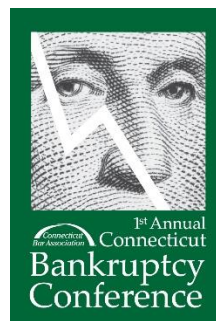

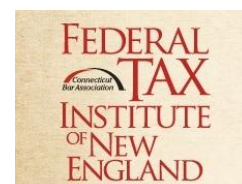
